Are you employed by the HSE or a related agency as a Support Staff Intern?

If you have answered Yes to the above you will be pleased to know that SIPTU has succeeded in negotiating a good deal for you.

Under the terms of the Lansdowne Road Proposals:

Support Staff Interns on reaching 18 months of employment from their date of commencement of employment will be made permanent and placed on the appropriate pay scale for their position and on the next favourable incremental point.

The pay element of the Proposals offer workers up to \leq 2,000 in restored pay over a two year period from 2016 to 2017. To see how this proposal would affect you see the pay scale on reverse.

Members of SIPTU have the opportunity to vote on the Lansdowne Road Proposals. If you are not a member of SIPTU and want to have a say on your future fill in the application form on the back of this information leaflet and you will be offered a ballot paper and opportunity to vote on the Proposals.

The ballot on the Lansdowne Road Proposals will commence on Tuesday, 23rd June, and conclude on Tuesday, 21st July. Contact your local Shop Steward or SIPTU Organiser for details of the ballot in your facility or service.
