



## Quick Guide for Healthcare Worker (HCW) Management 24<sup>th</sup> Nov 2021

No derogation required.</li> <li>'Fully Vaccinated†' - HCW must Restrict Movement for 5 days from when notified as household close contact by Public Health. Must complete 3 antigen tests - one every second day after notification. Can exit RM if asymptomatic 5 days after notified as household close contact by Public Health. even if all 3 antigen tests are not yet complete.</li> </ol> <p><b>Can be derogated to return to work following first Not Detected antigen or PCR test.</b></p> </li> </ol>
Close contact – PUI Covid Detected VOC case excluding Alpha and Delta variants	<p><a href="#">Restrict movements</a> (RM) for 14 days</p> <p>Test at day 0 and day 10;</p> <p>Can exit RM with both tests confirmed 'not detected' and return to work</p> <p><b>Derogation not possible</b></p>	<p><a href="#">Restrict movements</a> (RM) for 14 days</p> <p>Test at day 0 and day 10;</p> <p>Can exit RM with both tests confirmed 'not detected' and return to work</p> <p><b>Derogation not possible</b></p>
	<b>Unvaccinated HCW/No COVID-19 infection within previous 180 days</b>	<b>Vaccinated† HCW/Confirmed COVID-19 infection within previous 180 days</b>
HCW Returning from Travel	If HCW has a negative RT-PCR result from a test taken within 72 hours prior to arrival into the country, HCW can attend work. Quarantine no longer applies	HCW does not require restricted movement or testing and can attend work.
